#### 21/066 REPLACEMNT OF THE DAMAGED PARISH COUNCIL NOTICE BOARD

**21/066.1 Insurance** – the Clerk provided an update and asked the meeting to note that there will be a £125 excess to pay.

**21/066.2 Options for Replacement** – options for location, design, materials and installation were discussed.

**RESOLVED:** that the Clerk obtain costs from three potential suppliers of notice boards to meet the specification below. These will then be forwarded to the insurance company.

The following key specifications were agreed:

- the board should be located in the same place as the previous one
- the provider should complete the installation, removal of the stumps remaining from the previous board and disposal of the debris from the previous board
- a wooden top piece with the words engraved 'Willington Parish Council' should be provided
- the board should comprise of two A1 panels with two lockable glass doors, weather sealed
- the glazing in the door should be laminated glass

- the board should be made of English or European oak (including the back) finished with a microporous stain
- either a magnetic or 'soft' pin board material should be provided to hold documents
- the part of the posts that are underground should be suitably protected from rot (shrink wrapped, 'bitumened' or some other treatment).
